



LIMITED WARRANTY

WARRANTY

This warranty applies to physical products (rear and front projection projection films) and only to physical products (the "products"), purchased from the Adwindow screens company, during the warranty period. This limited warranty extends only to the original purchaser from Adwindow. This warranty covers defects in manufacturing and workmanship discovered while using the product as recommended by the manufacturer. The warranty period is **3 years** from the original shipping date of the product from Adwindow installations.

EXCLUSIONS

This warranty does not cover loss or theft, nor does coverage extend to damage caused by misuse, abuse, unauthorized modification, improper storage conditions, lightning or natural disasters. This warranty does not cover damage caused during the shipping or further transportation. If damage occurs during the shipping, it must be notified on the shipping documents at the time of reception for shipping warranty coverage. This warranty does not cover damage caused by a wrong or incorrect installation of the product. A full installation guide is available with manufacturer recommended installation details. Products must be inspected before installation. If manufacturing defects appear on the product prior to installation, damage must be declared for warranty before installation and the product must not be installed. This warranty shall be considered void if a product with defects is installed before contacting with the manufacturer.

Should the product fail, your sole recourse shall be repair or replacement. We will be not held liable to you or any other party for any damages that result from the failure of this product.
